1 Introductions

Dr Di Aitken welcomed members to the meeting and noted the topics discussed during the public forum that included:

- Learning disability health checks.
- Residents' issues accessing GP and dental appointments.
- Mental Health crisis response.
- Southeast London ICB Joint Forward Plan.

Action: Jane Bowie to communicate with Nicola Taylor outside of the Board meeting to discuss the fourth emergency service opportunity.

The following discussions were also had:

- Mental Health Week and the work being done across the Integrated Care Board and Lambeth Council to highlight this Andrew Eyres explained there were a range of events happening across the Civic Centre to support people to talk to each other. Dr Raj Mitra explained within Primary Care, talk around mental health happens all the time, ensuring staff are checked up on, making sure they take their full breaks and holiday entitlement and ensuring patients are asked about their mental health consistently. Cllr Jim Dickson stated there was a "Love Your Mind" workshop on Wednesday 18 May at Brixton library.
- Sarah Flanagan wanted to make it clear and for public record that men can now have a simple blood test to check for prostate cancer in the early stages of detection. Sarah Flanagan also mentioned the Volunteer Fair happening on the 1 June in Lambeth Town Hall and the Lambeth Country Show happening on the 10 and 11 June.
- Andrew Eyres talked about the Southeast London Joint Forward Plan and how work being completed by the individual six boroughs have fed into the Plan. For more information on the Joint Forward Plan, please visit <u>South East London's Joint Forward Plan</u>

Those present introduced themselves and apologies were noted from Fiona Connolly, Julie Lowe, Nozomi Akanuma, Dr Penelope Jarrett, and Sue Gallagher. It was noted that Sarah Austin would join the meeting at 3:00pm and Dr George Verghese would join the meeting intermittently.

A welcome was given to Anna Clough, who was deputising for Julie Lowe and to Virginia De La Hamayde and Ike Philip, who were observing the meeting.

Dr Di Aitken mentioned that it was World Hypertension Day on Wednesday 18 May.

2 Declarations of Interest

Members were asked to declare any conflicts of interests linked to the items on the agenda.

None were declared.

3 Review of Minutes

The minutes of the meeting of Wednesday 08 March 2023 were agreed as an accurate record of the meeting.



4 Lambeth Together Care Partnership - Place Executive Lead Report

Andrew Eyres provided an overview of key developments since the last Board meeting. The following was mentioned:

- Cllr Marcia Cameron wanted to add that she also attended the GP Federation visit in March, along with Andrew Eyres, Cllr Jim Dickson, and Dr Di Aitken.
- Dr Raj Mitra explained there are a lot of unhappy patients within Primary Care who have had their operations cancelled due to strike action and asked if there is a system-wide approach to manage the public's distress. Andrew Eyres explained trusts have been contacting patients where their operations have been cancelled and mentioned he could ask the trusts the extent to which they can reschedule operations in future but also noted that every time there is a strike, there is further impact.
- Dr Raj Mitra asked if there is any support for Primary Care and Andrew Eyres explained he didn't think so and asked if there was anything anyone could flag where they think help could be given. Andrew Eyres also stated it is most important that there are clear lines of communication for the future and explained if there was a lack of information coming from trusts, we can flag that with them.
- Dr Raj Mitra explained the Royal Mail strikes were also impacting patients as appointment letters were arriving too late and stated he would ask patients about what they feel could help them. Anna Clough explained the impact of the strikes had been monitored but wasn't sure what had been done as a result of this. Anna Clough also explained patients should be getting text reminders about their appointments and would find out where King's Hospital was in terms of rescheduling appointments.
- Dr George Verghese explained the Primary Care Access Recovery Plan talks about the
 interface between Primary Care and acute trusts and explained it is being investigated
 whether the acute trusts can arrange a single point of contact so patients can directly
 contact the acute sector, without having to ring around different phone numbers. Dr
 George Verghese also wanted to commend Andrew on his visit with Caroline Clarke as
 she now wants to showcase Primary Care and mental health to all the CEOs.
- Andrew Eyres explained Caroline Clarke was most impressed by the frontline staff she
 met and stated the team they met were very enthusiastic with how we can support
 mental health.
- Sarah Flanagan wanted to state that Guy's and St Thomas' send appointment letters by email, as well as by post. Andrew Eyres agreed that was his experience too but reiterated that not everyone has digital access and postal letters are just as important.

6 Lambeth Together Primary Care Commissioning Committee Update

Oge Chesa presented the update from the recent Lambeth Together Primary Care Commissioning Committee meeting on behalf of Sue Gallagher.

7 Lambeth Together Assurance Update

Warren Beresford presented the update from the previous Lambeth Together Assurance Group on behalf of Sue Gallagher.

The following discussion was had:

Dr Raj Mitra asked Warren Beresford if there was anything Warren was worried about this
month in terms of assurance. Warren Beresford explained the pressure on mental health
access had been raised and Guy Swindle from the Living Well Network Alliance was at
the assurance meeting to answer questions.



- Dr Raj Mitra asked if there was any data on the effect of the strikes yet. Warren Beresford
 explained the data isn't in real time and invited colleagues to comment on some of the
 pressures they may have been facing.
- Cllr Jim Dickson mentioned it may be worth noting the work on safer surgeries done by Primary Care Networks as more than half of our surgeries are now safe surgeries. Cllr Jim Dickson also mentioned that it was disappointing that only a few of the safer surgeries are saying so on their websites. Cllr Jim Dickson asked if we could take this issue back to the assurance group or Primary Care Networks. Cllr Jim Dickson reiterated it is great progress, but we need to let people know about it. Dr Di Aitken explained it may be to do with the issue of practice managers completing communications and engagement tasks on top of their day job, managing their staff and surgeries, etc. so communications and engagement may get lost along the way.
- Dr Di Aitken asked about the Adult Social Care pages in the assurance report and noted that the number of contacts, referrals, and conversion rates have decreased and asked if that was expected. Richard Outram explained it depended on the period that was being looked at and explained it needed to be looked at over a longer period and if going back over three years, you can see there was an increase during the pandemic as people contacted Adult Social Care with concerns at different points in time. We have seen over the last six months the figures tailing off to higher than we had pre-pandemic. We are facing people contacting Adult Social Care for other reasons apart from that and we are working with Paul Coles and Age UK Lambeth. Age UK staff are collaborating with Adult Social Care staff and offering different services to new users that contact Adult Social Care for fist time. 15-20% then go off to the voluntary sector and are looped back to their GPs. Paul Coles explained that Age UK are running a pilot with Adult Social Care where staff are taking calls from Adult Social Care and supporting them to identify help outside of the Adult Social Care sector to deliver the outcomes they want. It is important to recognise Adult Social Care can't always offer the support required and we are seeing great outcomes with this pilot and are piloting this for another year. Richard Outram mentioned bringing the outcome of the pilot back to the Board once it has finished.
- Richard Outram explained that Dr Raj Mitra reached out to him about an article he read on social work, and he was mulling over if there could be an interface with social work students and new GPs. Dr Raj Mitra wanted to spend time with a social worker and Richard Outram explained they are in the early stages of discussion on this.
- Cllr Marcia Cameron asked about the government giving funding to GPs to reduce appointment waiting times, amongst other things, and asked how this would work. Cllr Marcia Cameron also asked about GP training in mental health and was not sure what the uptake is by GPs; do they recognise the signs, know where to signpost patients, etc.
- Oge Chesa explained there is funding available to support Primary Care and assuming 100% is in the pot, 70% of that is already being paid to GPs monthly. The remaining 30% is subject to us working with practices to produce an access plan and the Primary Care team are working to produce a template to capture the GPs' plans on how their individual practice will deliver on the aims of the guidance. By 30 June, a draft submission from all practices on their initial thoughts on the plan will be ready. 30% of the fund will be released subject to delivery of the plan.
- Dr Di Aitken asked if the progress of the access plan would come back via the assurance report. Oge Chesa explained it would come back via the assurance report or the Primary Care Commissioning Committee so the Board will get an update on this.
- Dr Di Aitken explained completing hospital work in mental health is one of the vocational training options offered on the path to becoming a GP and confirmed most GP trainees should have done this. Cllr Marcia Cameron explained in a paper or meeting from about a



year ago, it showed that GPs did not know how to signpost to mental health services.

- Dr Raj Mitra explained all Lambeth GPs have protected learning time including mental health, so it is ongoing. Dr Raj Mitra explained we have talking therapy sessions, monthly Staying Well clinics and work closely with South London and Maudsley NHS Foundation Trust.
- Dan Stoten explained from a children's mental health perspective, there is a workstream
 to make sure there is sufficient mental health training for Primary Care colleagues and
 explained there is a difference in training for children so this workstream will ensure all
 skills are up to date.

8 Deep Dive: Sexual Health

Rachel Scantlebury, Nancy Padwick, Adrian Kelly, Joss Dempster, and Karen Mathieu presented on contraception services in Lambeth.

The following discussion took place:

- Dr Raj Mitra asked if termination rates are being cross-referenced and are these going up or down.
- Cllr Jim Dickson explained that reproductive health is a big priority, and that early medical
 abortion was made more available due to Covid-19. Cllr Jim Dickson also explained there
 has been a debate post Covid-19 to ensure early medical abortion arrangements were
 maintained and asked if we have seen a shift in the way abortion services are accessed
 since early medical abortion has been made more available.
- Rachel Scantlebury confirmed when looking at termination rates year by year, these have not changed much and explained it is difficult to interpret so this can reflect a lack of access to contraception but indicates good access to abortion services. The rates are broadly flat, coming down a little. Rachel Scantlebury explained we want people to have a choice with contraception and that some people will want to see their GP, some will want to access a clinic, and some would prefer an online service. Rachel Scantlebury agreed to look at the detail in the shift of the early medical abortions and would look at the pattern since Covid-19 and would bring this information back.
- Dr Raj Mitra stated condoms used to be available in the practice, but they were taken away and asked if they should be in the practice.
- Dr Raj Mitra asked Adrian Kelly if there is a frequent request for emergency contraception, is that a warning sign that some people should be on regular contraception.
- Adrian Kelly explained emergency contraception will always be monitored and when a
 woman repeats an order of emergency contraception, there is only a small number where
 this happens and the reason why women make those choices would be quite unique.
 There is an issue of access and groups we see taking emergency contraception struggle
 to get through barriers to get through to services so the question is for the rest of the



system about how they can be more approachable and acceptable.

- Dr Raj Mitra mentioned in his practice, those who have asked for emergency contraception end up having a termination, so something is not joining up. Adrian Kelly explained these are very complex issues.
- Karen Mathieu explained she did not know who took the condoms away but would explore
 this. There are posters and materials available so we can get some materials posted out
 to you. Karen will drop the email into the chat where you can request materials Dr Raj
 Mitra asked for this to be added to the Lambeth GP Bulletin.
- Dr Di Aitken asked a question on behalf of Dr Penelope Jarrett it seems there is insufficient capacity in the system, especially for Long-Acting Reversible Contraception but also getting appointments in sexual health clinics for infections and problems which cannot be managed by a GP. Online access has helped, and pharmacists managing pills will help, but neither can replace the work of the sexual health clinics. GPs would like to be able to do more Long-Acting Reversible Contraception, but the current payments are less than the costs of running the clinics, so they are running at a loss. Is there any way Lambeth Together can find more resource to expand overall capacity?
- Rachel Scantlebury explained women are telling us they do find it hard to get those
 appointments so would agree on the need for additional capacity. Payment is complicated
 as there are different arrangements with Primary Care and sexual health clinics. A survey
 is in development to understand more about the use of Long-Acting Reversible
 Contraception. Nancy Padwick explained work is being carried out with GPs to look at
 trialling different models and looking at a payment scheme.
- Dr Di Aitken will feed back to Dr Penelope Jarrett.
- Ruth Hutt explained in relation to Long-Acting Reversible Contraception and Primary Care access, we must encourage our GPs and nurses to get their training completed so it is easier to manage in-clinic. There has been feedback from patients having to make multiple appointments, so it is easier to streamline them for women the idea is to have a central booking system. Ruth Hutt also explained it would be helpful for GPs to be able to do the training if, for example, someone is on day four and coming in for emergency contraception, a GP can fit a coil. Free condoms are widely available, but we need to get messages out to young people about where to find that information.

Action: Rachel Scantlebury to review the detail around early medical abortions and the pattern since Covid-19 and feed back to Board members.

Action: Karen Mathieu to add email address for requesting contraception posters and materials into the chat so it can be added to the GP Bulletin.

Our Governance and Leadership

I would like to extend a warm welcome to our two new Board members. Lilian Latinwo-Olajide has joined as our Black Thrive Board member, succeeding Natalie Creary. We are pleased to have Lilian on board and look forward to benefiting from her valuable insights. Additionally, we are delighted to welcome Cllr Judith Cavanagh, who will be taking over from Cllr Ben Kind in relation to Children and Young People. We express our gratitude to Cllr Kind and Natalie for their contributions to Lambeth Together.

Furthermore, I would like to welcome Josepha Reynolds, who has assumed the Programme Director role for our Neighbourhood and Wellbeing Delivery Alliance (NWDA), bringing her expertise from the Southwark Partnership. Congratulations to Sophie Taylor on her new role as Lambeth Council's Director of Housing, and we extend our congratulations to Chris Moretti, who will be assuming Sophie's prior role as the Lambeth Together Programme Lead on an interim basis.

As part of the Organisational Development (OD) Programme mentioned in my last update, the Lambeth Together Care Partnership Board members met to consider our OD needs with the aim of developing our capability to work effectively together to deliver the ambitions in our Health and Care Plan - *Our Health, Our Lambeth.* Follow up actions will include our focus on equality, diversity and inclusion and taking forward our anti-racist approach, making best use of our time together, and ensuring ownership of key priorities across the system to enable change. 
Delivering Our Strategies

Across two days, the team delivered 348 BP checks, referring 39 patients back to their GP for follow-up.

National Windrush Day appreciates the contributions and achievements of the Windrush generation and their descendants to the UK, many of whom have contributed enormously to health and care services with the NHS, also turning 75 this month.

HRH Prince William - launches Homewards in Lambeth



On the 26th of June, Lambeth had the honour of hosting HRH Prince William as he visited the award-winning Mosaic Clubhouse in Brixton to launch the new Homeward Partnership. This initiative, led by the Royal Foundation, is a collaborative effort aimed at ending homelessness within a five-year timeframe. Lambeth was chosen as one of only six pilot areas across the UK to work together with committed individuals, organisations, and businesses to develop and implement locally tailored plans to prevent and ultimately eradicate homelessness. Each area will receive substantial support, including funding of up to £500,000 and the appointment of a dedicated local

lead to drive change at the grassroots level.

We recognise the severe impact of homelessness on individuals' mental, physical, and overall well-being, as well as their life opportunities. As such, the program seeks to adopt innovative approaches in preventing homelessness, with a specific focus on addressing the needs of often overlooked groups such as young people, women, and families facing domestic abuse, as well as single adults with complex needs.

Recent challenges in mental health services have underscored the vital role that stable housing plays in supporting effective discharges from inpatient care and overall health and care systems. By prioritising housing as an essential component, Lambeth's involvement in the Homeward Partnership aims to address these pressing issues and pave the way for transformative change in the lives of those affected by homelessness.

Industrial Action and System Pressures

As you may be aware, junior doctors, radiographers, and consultants have confirmed their intent to continue industrial action this summer. The latest strike by junior doctors will span a longer period, starting on Thursday, July 13th at 7am and ending on Tuesday, July 18th at 7am. Additionally, consultants will participate in strike action for the first time in the current dispute on July 20th and 21st. This prolonged period of industrial action, followed immediately by a weekend, will put significant pressure on our health and care services. We are working closely with all system partners to implement comprehensive measures that minimise disruption and prioritise patient safety across our services.

Despite the challenges, our collaboration and the dedication of our colleagues have enabled us to maintain many services during previous industrial action. The cumulative impact of prolonged strikes presents ongoing challenges for our health system colleagues. Our partners are proactively contacting patients to reschedule appointments as needed, and we continue to communicate with residents through multiple channels, guiding them to make use of the full range of available services in our system.

Our Programmes and Delivery Alliances

Children and Young People Delivery Alliance (CYP): Our Family Hub Start for Life Programme proposals have now gone through all required governance proposals, and we are implementing new commissioning and delivery arrangements to support programme delivery. In June, the Health and Well Being Board had a thematic focus on Best Start in Life and reviewed these proposals and the first Annual Learning Report from the LEAP (Lambeth Early Action Partnership) *A Better Start* initiative, now in its 9th year of 10. We are continuing to develop our established Emotional Health and Well Being Alliance group and to identify and take forward actions under this group. Recruitment for our Children's Brokerage and Specialist Placements service has progressed with permanent appointments made. The service is continuing to develop in accordance with programme plans.

Living Well Network Delivery Alliance (LWNA): As mentioned above, we are excited to be part of the Lambeth team to deliver the Prince of Wales' Homewards programme to end homelessness in 5 years, which was launched at the Alliance funded Mosaic Clubhouse. 'Home' - increasing the number of people living in stable and appropriate accommodation - is one of our 6 priorities. We have now recruited a team of Mental Health Practitioners, jointly funded by the Alliance and our GP colleagues and based in surgeries across Lambeth, who will be a central part of our Staying Well offer, supporting more people with their mental health in their own homes and communities and reducing the number that need crisis and long-term support. We continue to manage high demand

and various spells of industrial action whilst maintaining services and reducing the number waiting to be assessed by our Single Point of Access.

Neighbourhood and Wellbeing Delivery Alliance (NWDA): The Neighbourhood and Wellbeing Delivery Alliance (NWDA) held their final workshop on the evaluation of the Thriving Communities initiative, led by Dr Margaret Hannah of International Futures Forum (IFF). Present were Social Prescribing Link Workers from several representatives PCNs. and from Lambeth organisations. They introduced the roles of newly recruited Health Champions (Public Health) and Equity Champions (PCNs), fostering connections and understanding of work colleagues. Also in attendance Neighbourhood Nursing to explain their role and potential areas of collaboration. It was agreed that the group will be



responsible for growing the Thriving Communities work at scale, ensuring the governance is in place to ensure systems are safe and reliable at the neighbourhood level, and processes are embedded to ensure continued learning through practice.

Hypertension

AT Medics Practices in Streatham made the <u>news</u> with their work to address hypertension and that they have eliminated the inequalities in the control of hypertension between different communities in their practice populations. High blood pressure is a key cause of strokes and heart attack and has a much higher prevalence in Black, Asian and Multi-Ethnic populations and in deprived communities. Their work is a fantastic example of how we can drive improved outcomes for our population and, at the same time, address the gap in outcomes that exists between our black and white populations.

Childhood Immunisations

The pandemic saw a decline in the number of recorded child immunisations and vaccinations, resulting in an increased risk of infection and, in some cases, serious health concerns. Lambeth Together recognises that several factors have contributed to this decrease and addressing them is of key importance given the diverse nature of our population. As part of the implementation of the new 2023-25 Lambeth Childhood Immunisation Strategy, we have been working to address knowledge gaps and enhance confidence surrounding childhood vaccinations among parents, caregivers, and staff who interact with families that have children. To achieve this goal, we organised an interactive webinar, aiming to establish trust through focused outreach and to improve the understanding of parents and caregivers regarding the pivotal role of childhood vaccinations in protecting child health. The Strategy entails leveraging trusted assets such as children's centres and youth clubs to conduct face-to-face educational sessions with parents. Further collaboration across SE London is underway to plan additional virtual webinars for clinical and non-clinical staff who engage with parents and caregivers of children and young people.

Refugee Week

Lambeth celebrated our first Refugee Week last month as a new Borough of Sanctuary; this year's theme was "compassion". Lambeth Council co-hosted an event welcoming 22 London boroughs who have started the process to receive the Borough of Sanctuary award, as well as colleagues from the Lambeth Sanctuary Forum alongside sanctuary-seeking residents who are part of our resettled refugees, guests from Ukraine, residents currently accommodated in asylum-hotels and others affected by forced migration. Lambeth's Mayor gave an impassioned speech and awarded certificates to volunteers supporting sanctuary-seekers. You can see highlights of this fantastic held at the Lambeth Assembly Hall and decorated with artwork from Lambeth schools with messages of Freedom, Democracy, Equity, and Human Rights here.

Refugee Week was also the perfect opportunity for our GP surgeries to promote our "Safe Surgeries" which supports staff to recognise and address the barriers that many people face by implementing inclusive registration policies to ensure nobody in the community is excluded from primary care. Summary and Impact on Inequalities

The Primary Care Commissioning Committee (PCCC) is responsible for facilitating service users with accessible and equitable primary care services in our community. This includes services provided by General Practices, Dentists, Pharmacists, and Eye Care Specialists. The Committee's primary objective is to address and mitigate any healthcare inequalities within the community whilst improving access.

Key Functions:

(i) Equity of Provision: The PCCC ensures that all proposals and items it receives prioritise equitable healthcare provision to the population. It actively works to

- prevent the creation of unnecessary barriers that hinder people from receiving essential services.
- (ii) Impact Assessment: Before approving any major changes to the expected service delivery, the Committee conducts a comprehensive assessment of the proposed changes' impact. This assessment considers the potential effects on accessibility and ensures that funding is optimally allocated to guarantee inclusive and responsive service access for all.

Summary and Impact on Inequalities

Summary:

Board members to receive an update on progress developing the Lambeth Carers Strategy to date and the draft priorities.

Impact on Inequalities:

We know that unpaid carers are more likely to experience poor health outcomes, particularly poor mental health; when asked what the main issues and challenges facing carers are, 71% of Lambeth carers said managing their mental health and emotional wellbeing.

We know that unpaid carers are at greater risk of financial hardship; 900,000 full-time unpaid carers nationally - most of them women - rely on Carer's Allowance, which at only £76.75 a week is the lowest benefit of its kind.

Carers' health is known to be worse than that of non-carers due to the pressures of the role and is compounded by many factors. Caring has been announced as being a social determinant of health recently by Public Health England.

It is through the development of a refreshed Carers Strategy that we collectively seek to take account of these inequalities, changes and addresses new challenges which may have arisen.

To do this, the Carers Strategy development has involved groups across Adult's and Children's social services, Integrated Commissioning, partners from the voluntary sector, Young Carers, Young Adult Carers and Adult Carers.

Background



Our joint carers strategy, 'Working together with Families and Carers – A Framework for Action' was first published in 2017.

Summary and Impact on Inequalities


These slides set out the council's Cost of Living Response Plan 2023/4. The plan is designed to mitigate the impact of the cost of living crisis on the borough's most vulnerable residents.

The plan has four key objectives: responding to urgent need; minimising costs; maximising incomes; and building financial resilience. The plan acknowledges that, because of systemic inequalities the residents most impacted by the crisis are not representative of the Lambeth population as a whole and addressing these inequalities is central to the plan.






Local context: overall finances

Q. Compared with this time last year, do you think that your personal financial circumstances have improved, stayed the same or got worse? **Base:** all respondents (2,015)


Deep dive: proportion of residents whose finances have worsened

Q. Over the next year, how easy or difficult do you think it will be for your household to pay for the following...? Base: all respondents (2,015).




Local context: resilience and precarity




With inflation having peaked at the beginning of the survey period in October 2022, many residents reported being considerably financially precarious – the majority of residents feel unable to afford a £100 per month increase in the cost of living, and 1 in 6 feel they could not afford even a £5 per month increase. Although inflation is projected to fall sharply in the latter half of 2023, prices have and will continue to rise considerably month on month – meaning most residents are likely to struggle getting by.



For many Lambeth residents, the council's assistance in minimising costs is a lifeline. However, for those facing debt and other forms of financial insecurity, efforts to maximise income are equally critical.

Summary and Impact on Inequalities

All-Age Autism Strategy Consultation



As part of the development of the All-Age Autism Strategy a wide-reaching consultation exercise was conducted, welcoming feedback from autistic people and their families and professionals and services from across the health and care system.

People told us about their experiences of school and employment, access to health and care services and what does or doesn't work well in the system as it is currently.

Representatives from Autism Voice and the Parent Carer's Forum will attend the board to feedback on their experiences.

Tackling inequalities faced by autistic people is a key part of the strategy with a focus in Theme 4 on *Tackling Health and Care Inequalities*. The feedback received as part of the consultation brings a wealth of knowledge on how to improve access to and waiting lists for diagnosis, how to improve awareness and training on autism, and recommended reasonable adjustments which will be built into the action plan in the next stage.


Learning Disabilities Annual Health Checks (LD AHCs)

Lambeth is celebrating a successful achievement of 86% of people with LD receiving their annual health check (AHC) in 2022/23, against a national target of 75%. This is down to the hard work of GP practices in building relationships with their patients with support from the health promotion activities across Lambeth and SEL in recent years.

Data available from the AHCs on health outcomes show that in a number of areas, the health of people with LD is not significantly different from the general population. While this is positive, it also indicates that there are potential areas for further development in order to tackle the underlying reasons for the difference in life expectancy between people with LD and those in the general population.

Lambeth All Age Autism Strategy Development and Consultation



Vision

Individuals of all ages on the autism spectrum are valued and included in their communities. This includes providing access to early intervention and education services, as well as employment and housing opportunities that are tailored to the unique needs of individuals on the autism spectrum.

Context

National Strategy for Autistic People, Children and Young People 2021-26

sets out broad framework and requirement to develop borough-based strategies and associated action plans covering six areas

- 1) Improving understanding and acceptance of autism within society

Engagement with System partners









Professionals from across the South East London Integrated Care System were invited to take part in the engagement sessions, and will be key partners in developing the action plan in the next steps.

Feedback topics covered:

- Funding opportunities to continue providing collaborative, personalised community support
- Need for more effective **information-sharing** across systems and sectors (i.e. health and employment)
- Training opportunities for staff working in areas such as acute hospital trusts led by members of their team who have specialist knowledge about reasonable adjustments
- Thresholds around eligibility for social and health care support:
 - availability of autism-only support
 - difficulties during transition periods and accessing funding where individual has co-occurring conditions, despite needs being clear
 - there is feeling that support drops off for adults
 - Desire for reasonable adjustment flags across health system

Autistic Children and Young People's Priorities



The following themes were identified from conversations with young people at Autism Voice:

- Experiences of bullying at school and it was felt that there was not support for this
- This was often very traumatic for the young people and affected their mental health
- Some young people described feeling very lonely and not having many opportunities to make friends
- Young people also explained that they had negative experiences at work and that this included bullying or there not being reasonable adjustments.
- They also spoke of experiencing difficulties sustaining employment opportunities
- Young people spoke of how they enjoyed services like Autism Voice and felt very supported by the team; they enjoyed social activities including bowling.

Autistic Adults' Priorities



- Desire for clear diagnostic pathways for adults
- Recognition of the range of needs, including needs relating to autism and other conditions (e.g. MH/LD)
- More support which is accessible to autistic people with a range of needs
- Advocacy and empowerment there was support for promoting autism champions who provide advocacy and self-advocacy training
- Importance of tailored housing and employment support
- For services more widely to improve *understanding* of autism, not just awareness i.e. knowing what reasonable adjustments might be helpful

Learning Disabilities Annual Health Checks (AHCs)





Annual health checks are for people with a learning disability



You can get an Annual Health Check if you are aged 14 or older



An Annual Health Check is done by your doctor or your nurse once a year.

It is there to help you stay healthy



Lambeth and the NHS want **75%** of people with a learning disability to have a health check.

Last year **86%** of people had a health check. That's more than ever before!

Well done to primary care, carers, specialist services, the voluntary sector organisations and patients for this achievement!

- NHSE target: 75% of people of the GP register to access a health check
- In 2019/20 and 2020/21 Lambeth did not reach 75% due to the major impact on GP practices of the pandemic
- The general trend is upwards, with Lambeth reaching or exceeding 75% in 18/19, 21/22 and 22/23
- Note the number of people on the GP register is increasing, meaning it is increasingly challenging to reach the target



How did Lambeth achieve this target

By GP Practices / Primary Care

- Primary care has successfully integrated the health check into 'Business as usual'
- Practice staff are trained and experienced in communicating with people with learning disabilities, and are more successful at encouraging people to take up the health check
- Service improvement facilitators (SIF) are embedded in primary care to improve the collection and use of data and information
- Standard Quality and Outcomes Framework (QOF) incentive - no added incentives were needed to achieve these results.

System wide Health Promotion

- Through the NHS Exemplar Project, Lambeth commissioned Disability Advice Service Lambeth (dasl) to run an information and promotion campaign in 2021 on social media and directly with VSOs
- South East London Big Health Week a week of online and in person events
- Learning Disabilities and Autism Health Ambassadors people with lived experience undertake projects and engagement to increase awareness of AHC and health and wellbeing
- Question & Answer sessions at Carer's Hub led by Dr Nandi Mukhopadhyay






What do the health check data tell us about how well health care is managed?




- We now access data on health management measures which can indicate if people with learning disabilities (LD) are having worse outcomes than the general population
- HbA1c is a measure of blood glucose. An HbA1c of 58 or lower indicates good diabetes management and is positive for the individual
- Hypertension is when blood pressure is consistently too high. When someone is diagnosed with hypertension, a BP of 140/90 or less is positive for the individual
- People with LD are achieving slightly better outcomes for the indicators shown than people in the general population
- Note that number of people on the LD register is small relative to the general population



What do the health check data tell us about healthy lifestyles?



- A Body Mass Index (BMI) of 30 or over indicates you are obese and at risk of cardiovascular problems
- However, fewer people with a learning disability (LD) have a healthy weight compared to the rest of Lambeth
- Drinking less alcohol and being a nonsmoker is positive for the individual
- More people with learning disabilities are non-smokers and drink less than 14 units of alcohol a week when compared to the Lambeth general population
